

# **PAVE YOUR WAY TO R20 000 WITH COROBRIK:**

## **COMPETITION TERMS AND CONDITIONS**

1. These are the terms and conditions for the *Pave Your Way to R20 000 with Corobrik* competition conducted and promoted by Corobrik (Pty) Ltd (“Corobrik”).
2. Entry into the competition and/or acceptance of a prize (if won) constitutes the participant’s binding acceptance of these terms and conditions).

### **3. Competition Period**

- 3.1. The competition will run from 00H00, 1 August 2024 until closing at 23H59 on 31 January 2025. Late or incomplete entries will not be accepted.
- 3.2. The winner will be contacted within 14 working days of closing.
- 3.3. The duration of the competition may be shortened or extended at the sole discretion of Corobrik.
- 3.4. It is the responsibility of each participant to ensure that its entry is received by Corobrik prior to the closure of the competition. Any entries which are not received by Corobrik prior to the closure of the competition will be invalid, regardless of the reason for the late entry.
- 3.5. Without limitation, Corobrik is not responsible for any problems with, or technical malfunction of, any internet networks or telephone lines, computer on-line systems, servers or providers, computer hardware or software failure or malfunction, traffic congestion (whether physical, or on the Internet, telephone lines or at any service provider, website or other device or medium), or any combination thereof, or any other technical or other problems.

### **4. Eligibility for participation in the competition**

- 4.1 This competition is valid only in respect of purchases of, and projects using, Corobrik Modular Clay Pavers (including both PA & PB modular products in 50mm, 65mm, and 73mm thicknesses) within the competition period. Only one entry per project is permitted.
- 4.2 The participant must be either the homeowner or the contractor or both of them applying jointly, in respect of the paving project which is the subject of the entry submitted. Accordingly, the homeowner and the contractor must communicate with one another if either or both of them wish to submit an entry, in order to avoid duplicate entries.
- 4.3 An individual may not enter the competition more than once in respect of a single project. Anyone who enters the competition more than once in respect of a single project (using more than one account, if applicable) will be disqualified from the competition.

- 4.4 Contractors must have permission from the homeowner to upload project images and contact information before entering.
- 4.5 The project submitted must be a **residential** project.
- 4.6 Each participant must be a legal resident of the Republic of South Africa.
- 4.7 The entrant must provide all the correct information. Corobrik will not be responsible for incorrect information supplied to it and any participant not being contacted as a result.
- 4.8 If any of the data provided by an entrant to Corobrik in connection with this competition proves to be invalid, inaccurate, false or misleading, the entry shall be disregarded, and the entrant shall be prohibited from entering any further Corobrik competitions for a set period to be determined by Corobrik.
- 4.9 In the event that an uploaded entry does not conform to Corobrik's requirements, the entry will be invalid.
- 4.10 Participants will not receive any payment for taking part in the competition or taking part in any media format related to it.
- 4.11 A participant shall not be entitled to participate or receive a prize if it is unlawful for Corobrik to award the prize to the participant. If the prize is awarded to an ineligible participant, it will be subject to forfeiture and return.
- 4.12 Participants must be at least 18 years of age.
- 4.13 The competition is not open to:
  - 4.13.1 directors, members, partners, agents, employees or consultants of Corobrik or any other person who directly or indirectly controls or is controlled by Corobrik, or any other supplier of goods or services in connection with this competition; and
  - 4.13.2 the spouse, life partner, business partner or associate, or the natural or adopted parent, child or sibling, of any of the persons specified in 4.12.1 above.

## 5. **Competition Entry**

- 5.1. Any costs incurred by a participant in respect of and incidental to entering into the competition are for its own account.
- 5.2. To enter the competition, the relevant paving project must have been completed **AND** each **homeowner participant** or one of the joint participants, as the case may be, must have purchased any Corobrik Modular Clay Paver from one of

Corobrik's Sales Centres or accredited stockists during the competition period and each **contractor participant** must be the contractor who/which was responsible for providing the paving services for the project.

5.3. Each entrant must

5.3.1. upload images of the completed project to the Corobrik competition webpage using the entry form found on the website: <https://www.corobrik.co.za/paving-competition-2024> ; and

5.3.2. use the share button available after submitting the entry to share it and start gaining votes.

5.4. All votes must be submitted on the competition webpage: <https://www.corobrik.co.za/paving-competition-2024>.

5.5. Corobrik is not responsible for any entries which are not received by it, whether timeously or at all, regardless of the cause thereof.

5.6. Any costs or expenses which a participant may incur in respect of, or incidental to, participating in the competition shall be for its own account and shall not be recoverable from Corobrik.

## 6. Voting Eligibility

6.1. Voting is open to all individuals; bots or automated systems are not allowed.

6.2. Each individual is allowed to vote only once.

6.3. All votes must be submitted through the competition webpage: <https://www.corobrik.co.za/paving-competition-2024> .

## 7. Winner Selection and Reward:

7.1. The winner will be selected by public vote. The project with the most legitimate votes will be deemed the winner. Corobrik will engage an independent attorney or accountant to check the votes and determine/confirm the winner. In the event of a tie (that is, two or more entrants receiving the same number of legitimate votes), the winner of the competition will be determined by a "tie-breaker". In this respect, Corobrik shall, within the first week of February 2025, announce on the Corobrik website the names of the entrants who tied and they shall then be invited to procure "tie-breaker votes" from the public over a period of 24 hours. The details of when that period starts will be specified on the website, the intention being that it will follow shortly after the "preliminary winners" names have been published. Participants will be responsible for checking the Corobrik website for details and to keep themselves informed in this regard. The tie-breaker voting will be on the same basis as provided above, with each individual voter allowed to vote only once. The winner of the "tie-breaker" will be published on the Corobrik website as soon as reasonably practicable after the 24 hour voting period ends. If there is still a tie after the "tie-breaker vote", the prize shall be shared equally between those winners. The determination of the winner will be final, and binding and no debate or correspondence will be entered into.

- 7.2. Prize(s) are not transferable and may not be deferred, changed, or exchanged for any other item. If the prize is won by “joint participants” who enter jointly (that is, a homeowner and the contractor), the prize will be shared equally between them.
- 7.3. The winner(s) must possess a valid South African ID or proof of residency and proof of payment from a Corobrik Sales Centre or accredited stockist for the relevant Modular Clay Paving order.
- 7.4. The winner(s) will be notified via the contact details which were provided to Corobrik. If Corobrik is unable to contact a winner via such contact details within 14 working days or if a winner is unable to collect the prize within a reasonable time, the winner will forfeit the prize and Corobrik reserves the right to award that prize to the project which received the next highest votes.
- 7.5. Corobrik may invite the winner(s) to be present when the winner is determined or announced, to participate in any of its marketing activities, to appear in person and/or in the electronic media and/or print media, and/or to endorse, promote or advertise any of its goods or services, for which no fee, royalty or other compensation will be payable. The winner(s) may decline any such invitation.
- 7.6. Corobrik may publish the names of the participants and winner(s) on any of its communication platforms and may, for free, use any copies of the paving project photographs uploaded on its website .
- 7.7. Corobrik may require the winner(s) to provide it with such additional information and documentation as it may reasonably require for checking compliance with the rules of the competition and eligibility to receive the prize. If the winner(s) refuse to provide Corobrik with the requested information or documentation, it will forfeit the prize.
- 7.8. Corobrik reserves the right to vary, postpone, suspend, or cancel the competition and any prize(s), or any aspect thereof, without notice at any time, for any reason which it, in its sole discretion, deems necessary. In the event of any such variation, postponement, suspension or cancellation, each participant agrees to waive any rights, interests and expectations that it may have in terms of this competition and acknowledges that it will have no recourse against Corobrik or any of its employees.
- 7.9. Corobrik will not be responsible, and disclaims all liability, for any loss, liability, injury, expense or damage (whether direct, indirect or consequential) of any nature, whether arising from negligence or any other cause, which is suffered by a participant arising from its participation in the competition or from any action taken by Corobrik in accordance with these terms and conditions.

## **8. General:**

- 8.1. These terms and conditions will be construed, interpreted, and enforced in accordance with the laws of contract and dispute resolution in the Republic of South Africa.

8.2. Reference in these Terms and Conditions to the singular shall be deemed to include the plural and vice versa and reference to a particular gender shall be deemed to include the other genders.
